
INVESTMENT OBJECTIVE

The Edge BCI Balanced Fund of Funds a moderate risk profiled portfolio with the objective to offer investors a moderate long-term total return by investing across asset classes.

INVESTMENT POLICY

The portfolio will be managed in compliance with prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act, subject to a maximum net equity exposure of 60% of the portfolio's net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes. The investments will be consistent with the portfolio's primary objective, investing in equity securities, property and property related securities, nonequity securities, money market instruments financial instruments, bonds and other interest-bearing instruments and securities.


Moderate Risk
